- (iv) It is hereby undertaken that the company shall not:
 - (a) engage in any of the business mentioned in sub-clause (iii) above or any unlawful operation;
 - (b) launch multi-level marketing (MLM), Pyramid and Ponzi Schemes, or other related activities/businesses or any lottery business;
 - (c) engage in any of the permissible business unless the requisite approval, permission, consent or licence is obtained from competent authority as may be required under any law for the time being in force.
- 4. The liability of the members is limited.
- 5. The authorized capital of the company is Rs. 10,000 (Ten Thousand Rupees Only) divided into 1,000 (One Thousand) Ordinary shares of Rs.10 (Ten Rupees Only) each.
